NOTICE OF PUBLIC HEARING on the PROPOSED TAX RATE
and
MEETING to ADOPT TAX RATE

In compliance with the provisions of Chapter 551, Texas Government Code, and Texas Health and Safety Code Chapter 775, notice is hereby given of a Public Hearing conducted by the Board of Commissioners of the Ellis County Emergency Services District No. 6, to be held at the **ESD #6 VFD BUILDING LOCATED AT 1816 FM 66, ONE MILE WEST OF I-35E**, Waxahachie, Texas, at 6:30 p.m. on **Monday, August 19, 2024**.

The following agenda items will be discussed, considered, and action taken as appropriate:

I. Call to order, Roll Call, Certification of a Quorum, and Invocation

II. Public Comments

Any individual may address the Emergency Services District Board of Commissioners on relevant issues affecting the District that are either on the current agenda and/or are not a current agenda item, after completing the proper form, for not more than 3 minutes per agenda item or 3 minutes total on any items not on the current agenda. Any comment from a member of the public requiring deliberation or decision on an issue not on the current agenda will be addressed by; the District's Board only as authorized by Section 551.042 of the Government Code. **The Secretary must receive the completed request 10 minutes prior to the beginning of the Regularly Scheduled Meeting.**

III. Conduct a public hearing on the proposal to increase property taxes.

IV. Consider taking action regarding the budget for fiscal year October 1, 2024, to September 30, 2025;

A. Consider authorizing the payment of a monthly stipend of \$500 to the Assistant Chief of ESD6 VFD while this position is in charge of the monthly payroll and watch schedule.

B. Make final adjustments and then vote to adopt the budget for the coming fiscal year 2024-25 and a resolution for same.

V. Take a record vote on the District's 2024 tax rate, adopt an Order Levying Taxes, and authorize filing the Order with the Ellis County Tax Assessor / Collector.

VI. Acknowledge and approve posting of statement regarding adopted tax rate to the home page of the District's website.

VII. Financial Matters

A. Receive and approve payment of the ECESD#6 July 2024 bills. (Action required)

B. Review the financial report from the Treasurer for July 2024. (Action required)

VIII. Administrative Matters:

- A. **Approve the minutes of the July 10, 2024 regular meeting and the August 5, 2024 Special meeting on the Proposed Tax Rate. (Action required)**
- B. **Consider commencing the initial planning to renovate and expand ECESD6 VFD Station 2 by conducting a Special Workshop Meeting with local architect Anthony Mottla to discuss the design build process.**

- A. **Receive Chief Wes Curry's Forrester VFD monthly report** regarding operations, response times, call volume, training, management activities and membership. (Some items may require action)

 - **ISO review of the District** – Chief's report to commissioners
